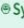

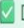

Executive Summary

Refinitiv demonstrates a **8.2/10 go-to-market viability score** with a **Medium risk profile**. This comprehensive analysis examines the company's strategic position across market segmentation, technology infrastructure, regulatory compliance, and competitive landscape.

The analysis reveals 6 key strengths, 5 areas for improvement, 6 growth opportunities, and 6 potential threats that require strategic attention.

- Revenue concentration risk with top 10 clients representing ~25% of total revenue
- Currency exposure across 190+ countries creating foreign exchange volatility

5. Enhance cryptocurrency and digital assets coverage to serve the growing institutional crypto adoption (>\$1.7T market cap)
6. Invest in RegTech solutions and automated compliance tools to address increasing regulatory requirements across global markets
7. Modernize core technology infrastructure with cloud-first architecture to improve scalability and reduce operational costs by 20%
8. Form strategic partnerships with fintech startups and technology companies to accelerate innovation and expand market reach

Conclusion

Refinitiv presents a 8.2/10 viability score for market entry and expansion. The company's 6 key strengths provide a solid foundation, while 6 identified opportunities offer clear pathways for growth.

However, the Medium risk profile requires careful attention to 3 regulatory challenges and 3 technology risks.

Key Success Factors:

- Implement the strategic recommendations outlined above
- Monitor regulatory changes and adapt compliance strategies
- Invest in technology infrastructure and cybersecurity
- Develop strategic partnerships to accelerate market penetration
